He asked me to share my screen and check any document was opened. Then he asked me to show the room and satisfied. Then he told me now he starting recording first he explained regulations and safety procedure during exam.

- 1) What is your last ship. (ship type) and where it was trading, (so I told him, I have sailed only on offshore vessel DP2 type.
- 2) So he gave me scenario, your company is just taken over a vessel (Bulk Carrier) from another owner, and all crew are almost new, vessel need to go for first loading of cargo soon and you are going as CE, please tell me takeover process.
 (looking for all safety equipments (lifeboat and davit, co2 room, emcy generator on load, emcy fire pump, emcy steering, Marpol equipments, navigation light, etc), cross question in form of what check you will do and what regulation about this system.
- 3) What is high voltage? And what precautions need to take before working on high voltage.
- 4) Scenario question: Now vessel is ok, everything onboard, you have 3 generators in which one is not working, and you need to sail to load cargo, next port is in 4 days. (Looking for redundancy, SOLAS regulation regarding Generator requirement).
- 5) Scenario question: this ship is UMS equipped, will you go on UMS now. (Said NO, as all crew is new, need to keep manned and periodical round of engine room need to take and need to be vigilant.
- 6) Going DD after 6 month, tell me process from start to end. (For making job list need to mention Any COC issued, any observation or NC from PSC, new Regulation in place to do some retrofit, CSM machinery, all survey equipment, and other defect.
- 7) What need to send to Dry-dock? (general arrangement, shell expansion plan, fire plan, capacity plan, shore connection details, FW & SW connection, sludge, Sewage, garbage and scrap collection, etc requirement.
- 8) Inspection of Rudder, propeller, stern post, bilge keel, sea chest grating, under hull, bulbous bow
- 9) Lowered anchor and chain in dock, what check need to carried out. (Wastage should not be more than 12 percent; chain link length should not be more than shackle length 27.5 meter.
- 10) What checks you will do at chain locker room? (Checked for buckling, crack, plate deformation, corrosion, plate thickness, NDT test on Bitter End.)
